What is a Carnet or ATA Carnet?

An ATA Carnet (pronounced *kar-nay*) is an internationally accepted customs document used for boomerang freight[™]. By presenting an ATA Carnet

to foreign customs, your *temporarily exported* merchandise or equipment passes duty and tax free into carnet countries for up to one year.

At the end of the year, all the items listed on the carnet return to the U.S., thus the term boomerang freight^{sst}. The ATA Carnet also serves as the U.S. registration of goods for re-entry into the U.S., duty and tax free.

Boomerang freight^{ss} can be sales samples, trade show booths, repair tools, musical instruments, laptop computers, presentation equipment, tools of the trade, photography, film or video equipment. Unusual items like livestock, artifacts, circus animals, aircraft and yachts are also acceptable.

With an ATA Carnet from *boomerang carnets* you'll spend less time with Customs, more time with customers.



Your ATA Carnet Cost The USCIB^{*} determines the Basic Processing Fees (cost) for ATA Carnets. The value of the goods determines the basic fee.

Additional costs are typically incurred for the required security or other services. Call or e-mail boomerang carnets^{sst} for a quote.

* The U.S. Council for International Business was appointed by U.S. Customs, now an agency of the Department of Homeland Security, to manage the ATA Carnet system in the U.S. Typically, the U.S. Council issues over 12,000 carnets a year covering goods valued at over one billion dollars.
